What is Fund Certificates?

Fund certificates are a type of securities issued by the Fund Management Company on behalf of Fund, in the form of journal entries or book entries, which certify lawful rights and the ownership of investors contributing capital to the Fund.

How to trade Fund Certificates?

cribed/redeemed directly or online through Fund's Distributors on trading days according to the Fund's regulations. Information about Distributors, Trading day is specified in the Fund's Charter and Prospectus. Within the framework of GFM-VIF, investors can make a subscription/redemption order fund certificates daily

What is NAV (Net Asset Value)?

NAV is net asset value of an fund calculated using formula:

NAV= Assets - Liabilities

NAV per fund certificate's price represents the net asset value of an open - end fund certificate at the time of valuation. NAV may increase/decrease depending on the Fund's investment performance

What kind of taxes and fees do investors need to pay when trading Fund Certificates?

What is cut-off time?

The deadline for Distributors to receive dealing orders from investors that shall be executed on fund certificate trading days.

Cut-off time of GFM-VIF is 2:30PM on a working day prior (T-1) to the Trading Day (T)

06

Standard investment (flex invest) or SIP?

Flex investment is a form of investing that investors are able to buy/sell their fund certificates at any time. SIP (Systematic Investment Plan) is an automatic method wherein investment planned in advance by investors with monthly, quarterly, etc. frequency according to the provisions of the Fund prospectus. SIP is a disciplined and convenient way of investing in the long term.

Who manages my money?

Mutual fund is professionally managed by a Fund Management Company. The Fund's assets are deposited and supervised by an independent Bank. The Fund Management Company and the Custodian Bank must both comply with the operating principles prescribed by the Fund and the Law, and obliged to make periodic reports to the SSC.

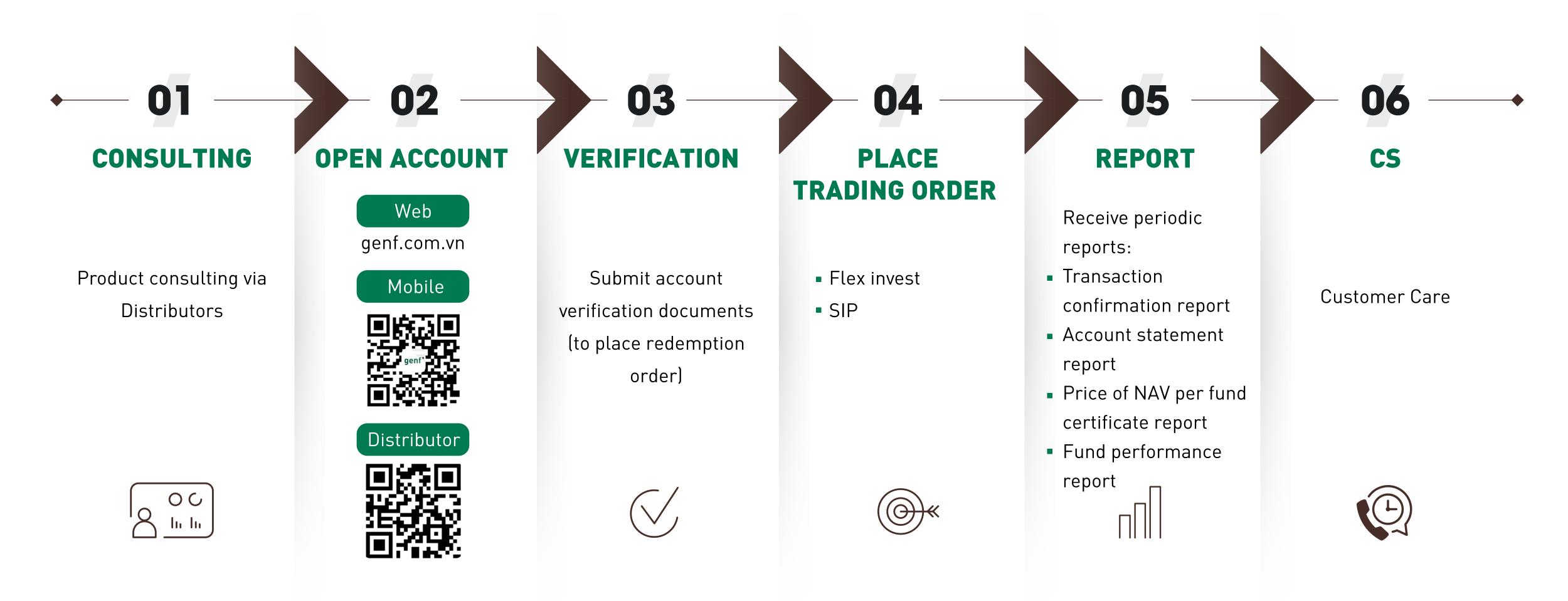

Is the fund committed for profit?

According to the Law of Vietnam, investment funds depend on market fluctuations, fund management companies are **not** allowed to comment on or guarantee income or profit on investors ' investment. However, the fund is managed by a professional fund management company according to pre-determined investment strategies to minimize risks and maximize **profits** for investors.

- 01 Certificate of securities trading code
- 01 Signed Account Opening Application Form
- 01 Signed Online Trading Service Registration Form
- 01 The Bank confirmation on opening a Capital Contribution Account (CCA) or the Indirect Capital Contributed Account (ICCA)
- Documents confirming FATCA status (if any)
- Other documents as required for Beneficial Owners or other purposes. Investors holding two or more nationalities are required to clearly state the other nationality and provide documents (if applicable)

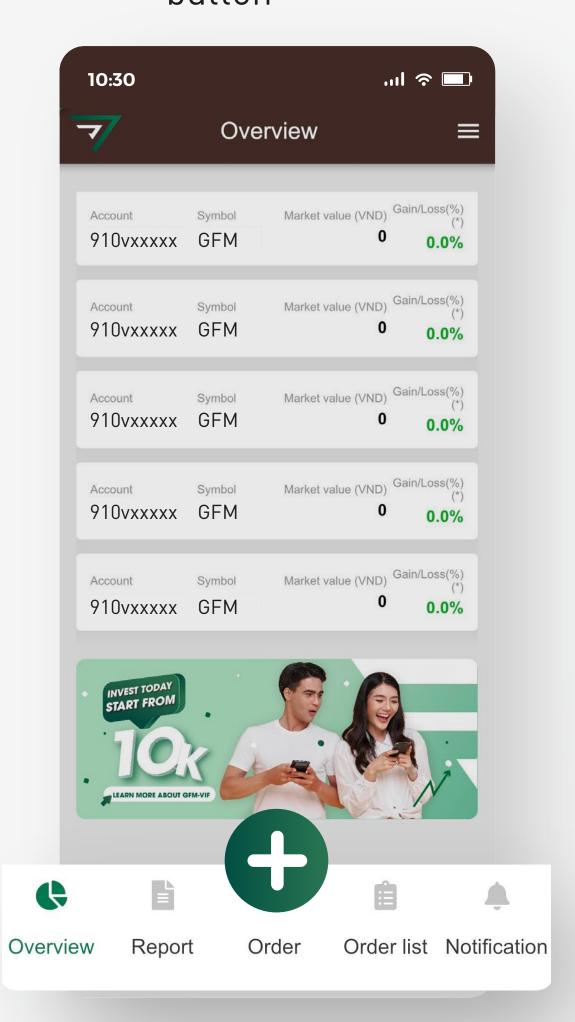


- Institutional investors and foreign investors, after declaring information to open an online account on GenF, foreign investors will complete the documents (full signature) for GFM before making transactions

- Investors can only perform transactions after fully supplementing the original documents according to regulations

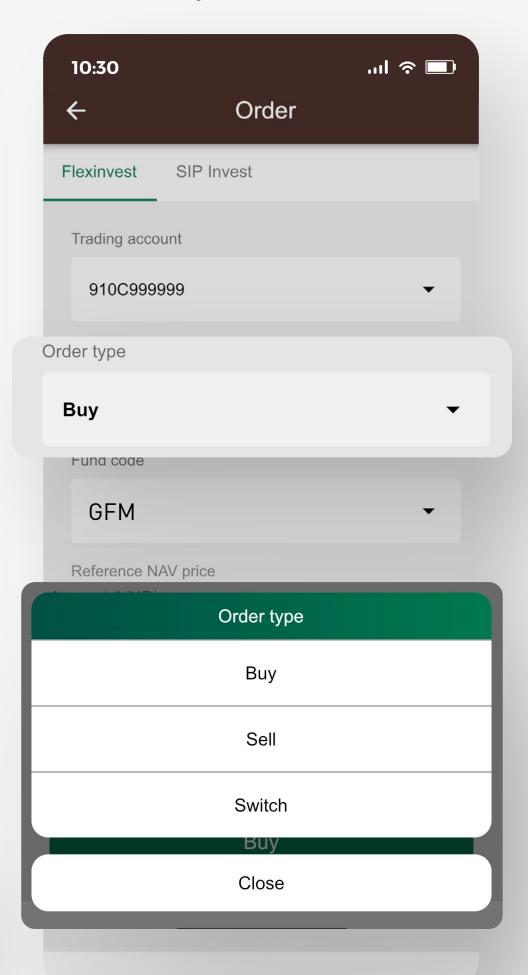
